Frequently asked questions and answers are for general information only with any final assessment of Claimant Eligibility or Claim amounts based only on the court-approved Claims Administration Procedure.

Question	Answer
1. Who can make a claim for the costs associated with having to relocate due to the 2011 Flooding?	Any Claimant Individual, Business, Not-For-Profit or Farm off-reserve that incurred costs as a result of forced temporary relocation due to the flooding.
2. What types of costs will be covered under the relocation costs?	<p>The Claims Administration Procedure includes the following <u>reasonable losses and costs</u> that may be claimed with the amount(s) of compensation based on the Claims Administrator’s sole discretion and assessment:</p> <p>Individuals that owned or rented Principal Residences, Business, Not-for-Profit and Farm Properties can claim:</p> <ul style="list-style-type: none"><li>▪ Moving Costs</li><li>▪ Storage Costs</li><li>▪ Rental and Accommodation Costs</li></ul> <p>Individuals that owned or rented <u>Non-Principal Residences</u> can <u>ONLY</u> claim:</p> <ul style="list-style-type: none"><li>▪ Moving Costs</li><li>▪ Storage Costs</li><li>▪ <b>NO</b> Rental and Accommodation Costs</li></ul>

Question	Answer
	<p>Note: Any compensation received from the Original Government Financial Assistance Program or any other flood compensation source will be deducted from the assessed compensation amounts.</p>
<p>3. What type of evidence do I need to provide?</p>	<p>The following are some examples of Moving / Storage / Accommodations Rental Expenses:</p> <ul style="list-style-type: none"><li>▪ Supplier Invoices of Moving expenses both from and returning to the property.</li><li>▪ Supplier Invoices of Storage expenses.</li><li>▪ Accommodation Rental Agreements and Copies of Cancelled Cheques or Funds Transfers.</li><li>▪ Costs reported to MASC.</li><li>▪ Proof that the Claimant’s property could not be lived / worked in during the period claimed.</li></ul>

Question	Answer
4. Can I claim for my personal or relatives' time and costs for my relocation?	No. The Claims Administration Procedure does <u>NOT</u> include Claimant's or their Relatives': <ul style="list-style-type: none"><li>▪ Personal Time and Costs.</li><li>▪ Personal Fuels Costs.</li><li>▪ Personal Storage Charges.</li><li>▪ Personal Accommodation Rental Charges.</li></ul>
